Bowls North is committed to ensuring that all Players and Officials always present a professional image. The following guidelines are in place to guarantee that this carried out.



BOWLS NORTH INC UNIFORM POLICY

1. PLAYERS

▪ OPEN TEAMS

- a) Players representing Bowls North will be supplied with a complete uniform on loan (Playing Top & Spray Jacket/Hoodie). This must be returned at the completion of the event, (Please refer section 3 'Loan Process'). Players do have the option to purchase garments at a price determined annually by the Bowls North Board.
- b) Any additional garments requested by a player are at the players own cost.
- c) A uniform order form must be completed by the player and signed (Appendix 1)
- d) Any replacement garments required for any following events are at the players own cost.

▪ JUNIOR TEAM

- a) The Bowls North uniform will be on loan to the Junior player. Players do have the option to purchase garments at a price determined annually by the Bowls North Board.
- b) A uniform order form must be completed by the player and signed. (Appendix 1)
- c) Any replacement garments required for any following events are at the player's own cost.

▪ SENIOR TEAM

- a) Players representing Bowls North will be supplied with a complete uniform on loan (Playing Top & Spray Jacket/Hoodie). This must be returned at the completion of the event, (Please refer section 3 'Loan Process'). Players do have the option to purchase garments at a price determined annually by the Bowls North Board.
- b) Any additional garments requested by a player are at the players own cost.
- c) A uniform order form must be completed by the player and signed (Appendix 1)
- d) Any replacement garments required for any following events are at the players own cost.



2. OFFICIALS

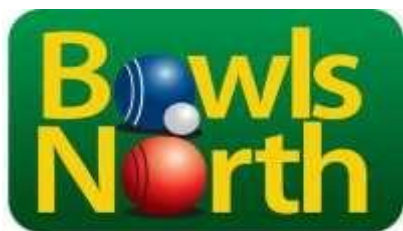
- a) All officials will be provided with a complete uniform (Top and Spray Jacket/Hoodie) on a loan basis only. This must be returned to Bowls North at the completion of the event.
- b) This uniform will be the same design as the playing top.
- c) If officials require alterations to these garments, then the garments must be purchased by the official.

3. LOAN PROCESS

- a) All loan items will be numbered
- b) Player/Officials must sign a loan form indicating the numbered garment they have borrowed. Loan forms are to be filed and kept by the Bowls North office (Appendix 2)
- c) The player/official will be responsible for loss and damage to the garments on loan to them and will be issued with an account if garments are not returned in an appropriate state as deemed by Bowls North.
- d) Uniforms must be returned to Bowls North including the return form (Appendix 2)

4. RETURN OF UNIFORM (INCLUDING LAUNDERING OF ITEMS)

- a) All player/officials who are issued uniforms on loan must ensure all garments are returned to the Bowls North office within seven (7) days of the completion of scheduled play.
- b) It is strongly recommended where possible that loan uniforms are returned to Team Manager at completion of competition and that appropriate paperwork is completed at that time.
- c) If not given to Team Manager, the uniform must be returned Bowls North Office.
- d) Bowls North will be responsible for all laundering of uniforms once returned after use.
